**NEW BUSINESS**

- **Subcommittee Goal updates**
  - **Health education/Physical and Education/Staff Wellness:** Each campus is completing the fitness gram data.
  - **Nutrition Services:** Each campus is working on increasing lunch and breakfast numbers. By offering new lunch menu options. Training to adequately prepare and effectively deliver the program is scheduled for staff July of 2023.
  - **Health Services/Healthy Safe School Environment:**  
(Health Services) Each campus is working on completing the yearly health screenings. All Seniors are not CPR certified.  
(Healthy Safe School Environment) Working on bids for projects for the summer for the Safety facility grant for new safety requirements. At this time we are working on a 3 year safety audit for the district. O.I.S.D. now has an RSO on each campus and we will now have K9 returning as well. The employee fitness gym is scheduled to be open by summer of 2023
  - **Counseling and Mental Health Services:**  
Elementary Campus: Will meet their goal of monthly guidance lessons by May.  
OJSH: Teachers are working hard to communicate with counselors about the needs of the students. Sexual Harassment training with the 8th grade students will start once approved by school board at the Apr 17, 2023 board meeting.
  - **Parent and Community Involvement:** Due to service providers being booked for the spring semester. We are on track to schedule the health fair in October of 2023.
